## **Privacy Policy**

#### Introduction

This notice is to help you understand how and why we collect personal information about you and what we do with that information. It also explains the decisions that you can make about your own information.

#### What is personal information?

Personal information is information that identifies you as an individual and relates to you. This includes your contact details and financial information. CCTV, photos and video recordings of you are also personal information

#### About us

The Stowe House Preservation Trust (SHPT) is a charitable organisation. In line with the General Data Protection Regulations (GDPR) 2018 and the Data Protection Act 2017, SHPT and its trading arm, Stowe House Enterprises Ltd (SHEL) makes every effort to comply with these principles.

#### What information do we collect about you?

When you book on-line for a visit, or an event via our website, when you sign up for volunteering, make a group booking or when you enquire via telephone we collect information about you. This information may only be a telephone number, your full postal and e-mail address depending upon which of our services you have used.

#### How will we use the information about you?

This information about you is used to process your orders and bookings, manage your account, process your applications and to email you about other products, services and promotions we think may be of interest to you.

We would like to send you information about restoration, events, volunteering, fundraising and other activities.

We will never pass your information onto outside agencies.

Your personal data will be used:

- To enable us to provide a service for the benefit of the public as specified in our constitution
- To fundraise and promote the interests of the charity;
- To manage our employees and volunteers;

 To inform you of news, events, activities and services running at Stowe House

#### We will endeavour to:

- Collect your personal data for relevant and limited reasons
- Process your personal data in a clear and transparent way.
- Collect your personal data for explicit and legitimate reasons
- Keep your personal data with the appropriate security levels
- Keep your personal data accurate and up to date

#### **Online Ticketing**

We use third party provider, PayPal to process payment of online ticket sales. We do not have access to any information collected by them other than your name, email address and ticket information. For further details please see PayPal's privacy notice.

If you decide to upgrade your ticket to a free annual pass, your name, address, email and photograph will be collected and stored in our box office system Gamma. Please be assured that we do not share your personal details with any other company without your consent.

However, if you would prefer not to provide us with any of your personal information, you can buy tickets in person at the Stowe House Welcome Centre.

#### Marketing

If you have consented to receive the marketing mentioned above you may opt out at a later date and to stop us from contacting you for marketing purposes. This can be done by clicking on the unsubscribe link in any marketing email received.

As part of the registration process for our monthly e-newsletter, we collect personal information. We use that information for a couple of reasons:

- To tell you about information you've asked us to tell you about
- To contact you if we need to obtain or provide additional information
- To check our records are right and to check every now and then that you're happy and satisfied.

We use a third-party provider, MailChimp, to deliver our newsletter. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our e-newsletter. For more information, please see MailChimp's privacy notice. We may ask you to verify your identity before supplying the information with appropriate identification.

#### **Cookies**

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. This information is used to track visitor use of the website and to compile statistical reports on website activity. It may also be used to optimise your experience on our website.

We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website.

#### Security

Stowe House Preservation Trust holds your personal data in accordance with the security provisions of the UK Data Protection legislation. We use industry standard Secure Server Software (SSL) for your transactions with us. It encrypts all of your personal information, including credit card number, name and address, so that it cannot be read as the information travels over the internet.

# Stowe House Preservation Trust SHPT)/Stowe House Enterprises Limited (SHEL)

#### What information do we hold?

### SHEL holds:

- Information from members of the public captured from Stowe House event bookings, group bookings, education bookings, e-newsletter sign up (names, postal and e-mail address, photo)
- Information from members of the public making on-line bookings (names and e-mail address)
- Information from volunteers, past and present (names, postal and e-mail address, telephone numbers, photo, CV)
- Information on past and present members of staff (names, postal and e-mail address, photo, CV)
- Information on past and present trustees (names, postal and e-mail address, photo, CV)
- Information gathered from members of the public regarding photographic consent

## SHPT holds:

- Information on descendants (living and deceased) of the Temple-Grenville family (names, county of location, date of birth)

## Why do we need this personal information?

We use this personal information to tell our visitors, members and volunteers about our events and monthly news. We never pass personal information onto third parties outside of Stowe House and Stowe School.

How do we communicate our new policy to the public?

The new policy will be available on our website and can be emailed or posted upon request.

## What procedures do we have in place to cover individual's rights?

We are able to delete or change personal data upon request.

We are able to provide personal data electronically.

We are able to facilitate access requests to personal data upon request.

## How do we seek, record and manage consent?

We collect personal data via:

- the Stowe House website (booking information)
- volunteer recruitment (CV information)
- electronic tablets and paper surveys (booking information)

At each of these points of contact, we will ask, via a tick box, that we can retain personal information. We also make clear that this personal information can be accessed, changed and deleted upon request.

# Do we keep any children's personal data?

We have personal information on young people under 18 if they have volunteered for SHFL.

# How do we prevent data breaches?

Any personal information, no matter where it originates from, is kept under password-protected or locked filing cabinet. Only SHPT members of staff have access to this information.

It is our responsibility to detect, report and investigate and data breaches.
